India's gross domestic product (GDP) is estimated to grow at 8.9% in 2021-22 instead of the 9.2% estimated earlier, with year-on-year growth during October-December 2021 slipping to 5.4% from 8.5% in the previous quarter, as per the second advance national income estimates released.

Gross Value-Added (GVA) in the economy is expected to grow by 8.3% this financial year, from a 4.8% contraction in 2020-21, the National Statistical Office (NSO) India's GDP shrunk 6.6% in 2020-21, with the first half of the year recording a sharp contraction before GDP resurfaced to clock 0.7% growth in the October-December 2020 quarter.

Economists expect the full year growth hopes for this year to be pared further from the 8.9% projected by the NSO, especially in light of the high oil prices as well as inflation trajectories.

The GDP growth rates for the first and second quarters of 2021-22 were revised upwards marginally by the NSO from 20.1% to 20.3% and 8.4% to 8.5%, respectively.

India's gross domestic product (GDP) is estimated to grow at 8.9% in 2021-22 instead of the 9.2% estimated earlier, with year-on-year growth during October-December 2021 slipping to 5.4% from 8.5% in the previous quarter, as per the second advance national income estimates released on Monday.

Gross Value-Added (GVA) in the economy is expected to grow by 8.3% this financial year, from a 4.8% contraction in 2020-21, the National Statistical Office (NSO) said. Barring the contact-intensive segment of trade, hotels, transport, communication & services related to broadcasting, all sectors are expected to surpass pre-pandemic GVA levels this year.

While the Ministry of External Affairs has been running helplines and officials are posted at border checkpoints at Poland, Hungary, Slovakia, Romania and Moldova, the rush at these checkpoints, especially on the Poland-Ukraine border, has seen clashes there and a wait of two to three days in freezing temperatures before making a crossing. Sources in the government said that while private airlines such as Indigo and SpiceJet had also announced evacuation flights, the presence of Ministers may help ease some of the paperwork required to complete the process.

## SDG goals: India slips to 120th rank

New Delhi, March 1 India has slipped three spots to rank 120 on the Sustainable Development Goals adopted as a part of the 2030 agenda by United Nations member states in 2015, a new report said.

With the latest rankings on the 17 SDG goals, India is now behind all South Asian nations except Pakistan, which stands at 129. Bhutan is ranked 75, Sri Lanka 87, Nepal 96 and Bangladesh 109. India's overall Sustainable Development Goals score was 66 out of 100.

#### Poor performance

According to the Centre for Science and Environment's State of India's Environment Report, 2022, released by Union Environment Minister Bhupender Yadav on Tuesday, India's rank dropped primarily because of major challenges in 11 SDGs including zero hunger, good health and well being, gender equality and sustain-

able cities and communities. India also performed poorly in dealing with quality education and life on land aspects, the report stated. The previous year, India had suffered on ending hunger and achieving food security, gender equality and building resilient infrastructure, promoting inclusive and sustainable industrialisation and fostering innovation.

On the State-wise preparedness, the report said Jharkhand and Bihar are the least prepared to meet the SDGs by the target year 2030.

Kerala ranked first, followed

by Tamil Nadu and Himachal Pradesh in the second position. The third position was shared by Goa, Karnataka, Andhra Pradesh and Uttarakhand. Among the Union Territories, Chandigarh was ranked first, followed by Delhi, Lakshadweep and Puducherry in the second place and the Andaman and Nicobar Islands on the third, the report said.

The 2030 Agenda for Sustainable Development, was adopted by all 192 United Nations Member States in 2015, which provides a shared blueprint for peace and prosperity for people and the planet. There are 17 Sustainable Development Goals which are an urgent call for action by all countries in a global partnership. Some of these goals are no poverty, zero hunger, good health and well being, quality education, gender equality, clean water and sanitation, affordable and clean energy, decent work and economic growth, industry, innovation and infrastructure.

The Centre's focus on natural farming through traditional method can get a leg up as the latest report of the Intergovernmental Panel on Climate Change (IPCC) has said that indigenous, traditional and local knowledge have increased drought resilience among crop and livestock farmers in India. It has also warned that the country will be seriously harmed if emissions are not cut amid rising temperature.

According to the second installment of IPCC Working Group II report on *Climate Change* 2022: Impacts, Adaptation and Vulnerability, "Only 7 per cent of all disaster events were droughtrelated between 1970 and 2019, yet they contributed disproportionately to 34 per cent of disaster-related death, mostly in Africa." Climate change and rising demand mean about 40 per cent of people in India will live with water scarcity by 2050 compared with about 33 per cent now, according to a study cited by the report.

#### Repercussions

Both the Ganges and the Brahmaputra river basins will also see increased flooding as a result of climate change, particularly if warming exceeds 1.5° C.

In India, rice production can decrease by 10 to 30 per cent and maize 25 to 70 per cent assuming a temperature increase of 1° to 4° C, it said.

These factors, along with saltwater intrusion from sea-level rise, will harm agriculture in India, which, according to the report, is the most vulnerable country in Asia in terms of crop production. Rice, wheat, pulses,

coarse cereal yields could fall almost 9 per cent by 2050. In South India, maize production could decrease 17 per cent if emissions are high. These disruptions are expected to cause price spikes, threatening food affordability, food security and economic growth.

#### Wet-bulb temperatures

Also continued climate change will cause a decline in the fisheries output. Referring to wet-bulb temperatures, a measure of heat and humidity, the report warned that if emissions continue to rise, wetbulb temperatures will approach or exceed the unsurvivable limit of 35° C over much of India, and 31° C or more over majority area.

"Currently, wet-bulb temperatures in India rarely exceed 31° C, with most of the country experiencing maximum wet-bulb temperatures of 25-30°," said the report. A wet-bulb temperature of  $31^{\circ}$  C is extremely dangerous for humans and  $35^{\circ}$  C unsurvivable for more than about six hours, even for fit and healthy adults resting in the shade.

#### Water scarcity

"By mid-21<sup>st</sup> Century, the international transboundary river basins of Amu Darya, Indus, Ganges and inter-State Sabarmati-river basin in India could face severe water scarcity challenges with climate change acting as a stress multiplier," it said.

Warning about the sea level rise, the report said, "By the middle of the century, around 35 million Indians could face annual coastal flooding, with 45-50 million at risk by the end of the century if emissions are high," it said.

## GST revenues cross 1.3 lakh crore in Feb.

The Gross Goods and Services Tax (GST) revenue in February was 26% higher than the pre-pandemic levels at 71,33,026 crore, the Finance Ministry said.

The collections are 18%

higher than those of February 2021 and mark the fifth time that GST revenues have crossed ₹1.3 lakh crore since its launch in July 2017.

Revenues from import of goods were 38% higher yearon-year, while revenues from domestic transaction,

including import of services, were 12% higher than the revenues from these sources during February 2021.

GST Compensation Cess collections crossed ₹10,000 crore in a month for the first time in February, which the Ministry said "signifies recovery of certain key sectors, especially, automobile sales".

The cess collections in February were ₹10,340 crore, and included ₹638 crore collected on import of goods.

A bench of justices Dhananiava Y Chandrachud and Surva Kant took the report on record and said, "All concerned agencies, including Noida authority and Supertech will strictly comply with the time schedule in the report. Posting the matter for May 17, the court directed Noida authority to file an updated status report before the next date of hearing. The Supreme Court ordered the demolition of the twin towers on August 31 last year, after the residents of the project claimed that the buildings were in violation of the National Building Code.

While the official statement only spoke about the infra meeting, sources told Business Standard that a similar webinar will be held on privatisation, asset monetisation, and other divestment plans of the government on Wednesday. These are part of a series of post-Budget interactions being chaired by the PM and organised by various ministries on the implementation of the Budget announcements.

"Representatives from various infra companies, real estate

investment trusts, infra invest ment trusts, and funds will attend the webinar on Tuesday. The focus will be on various means of infra financing, project implementation, and opportunities for private sector," said an official.

According to the ministry, the webinar will have breakaway sessions on themes, including infra financing, financing sectors with high employment potential, cre-ating enablers of infra, navigating the digital opportunity for banking and finance, climate and sus-

tainable finance, and financing for sunrise sectors.

"Through the webinar, the Ministry of Finance seeks to get valuable inputs on ways to

accelerate the pace and achieve the agenda of the themes. By leveraging stakeholders' expertise and experi-ence, an action plan for effective implementation of growth reforms will be catalysed," it said.

High-multiplier infra projects are the main thrust of the Centre's plans to revive the economy after three waves of the Covid-19 pandemic. The focus will be on roads, railways, airports, ports, mass transport, waterways, and logistics infra, as laid down in the PM Gati Shakti Mission. The Centre will also provide push in energy transmission, technology, bulk water and sewerage, and social infra.

To this end, the 2022-23 (FY23) capital expenditure (capex) target as laid out by Finance Minister Nirmala Sitharaman is ₹7.5 trillion, which includes ₹1 trillion in 50-year interest-free loans to states for their capex needs.

PUNE: Prime Minister Narendra Modi unveiled a statue of Chhatrapati Shivaji Maharaj at Pune Municipal Corporation and inaugurated a slew of development projects, including a 12 km stretch of the Pune Metro Rail Project, during his visit to the city on Sunday.

The Prime Minister, who landed at the Lohegaon International Airport here at 10.30 am. began his tour by visiting the municipal corporation headquarters to unveil the 9.5-feet tall statue, which is made up of 1,850 kg of gunmetal. He also paid floral tribute at a statue of social reformer Jyotiba Phule.

"Unveiled a statue of Chhatrapati Shivaji Maharaj in Pune. His life and ideals are a source of great inspiration," he tweeted.

Following this, the Prime Minister flagged off the Pune metro rail project at Garware metro station and proceeded to take the metro ride to Anandnagar station, nearly five km away.

Built at a cost of over ₹11,400 crore, Modi had laid the foundation stone for the metro project on December 24, 2016.

# 81 infra projects make it to Gati Shakti list

Road projects top the pecking order, states to upload data by March-end

New Delhi, 6 March

he industry department has identified 81 highimpact projects under various infrastructure ministries for the government's Gati Shakti initiative. These projects will be closely monitored in 2022-23, according to officials.

Major industrial corridors of National Industrial Corridor Development Corporation (NICDC), key expressways and highways, such as 1,257-km Amritsar-Jamnagar expressway, 1,350-km Delhi-Mumbai expressway, and 210-km Delhi-Saharanpur-Dehradun expressway, and the world's largest broadband project BharatNet will be among the government's priority projects, two officials told Business Standard.

Of the 81 high-impact projects that have been identified, 50 per cent belong to the ministry of road transport and highways, followed by others. "These projects have been tagged under PM Gati Shakti and are being closely monitored," said one of the officials cited above.

The development assumes significance, with the government pinning Gati Shakti as one of its four priorities for the next financial year. as laid out in the Union Budget 2022-23. Speedy implementation of infrastructure projects is expected to have a multiplier effect by cre-



accelerating growth.

Launched by Prime Minister Narendra Modi in October 2021, Gati Shakti - a digital portal - is currently in a test phase; officials said a full-fledged launch can be expected by the end of this month. An exercise is being conducted to integrate the existing portal and data of key ating demand and jobs, thereby infrastructure ministries, as well as

state governments. The Union Budget 2022-23 has made a provision of assistance worth ₹1 trillion for states so that state governments can use this amount on multimodal infrastructure. Turn to Page 4 }

# UN environment meet: 175 nations sign mandate to curb use of plastic

ONE HUNDRED and seventy-five countries, parties to the United Nations Environment Assembly, on Wednesday signed a mandate which makes it legally binding for the signatories to address the full life of plastics — from production to disposal, to end plastic pollution. An International Negotiating Committee will now be tasked with drafting and ratifying over the mandate over next two years.

A Global Plastics Treaty adhering to the blueprint laid out in Wednesday's mandate will join the Montreal Protocol and the Paris Climate Agreement as one of the most significant international environmental laws in history.

"Historic step at UNEA 5.2. 175 nations endorse a resolution to beat plastic pollution and forge an international legally binding agreement by 2024. Under leadership of our PM Narendra Modiji, India has already taken resolute steps to address plastic pollution," Environment Minister Bhupender Yadav tweeted.

According to the mandate, the treaty will tackle the whole life cycle of plastic — not just post-consumer waste. This is a critical shift in policymakers' approach, which previously focused on plastic as a "marine litter" issue. The mandate recommends measures to tackle plastic production, which as of now is slated to almost quadruple by 2050, and take up 10-13% of global carbon budget, endangering climate. It also recommends addressing the toxic burden of plastic.

Dharmesh Shah, senior technical adviser with Legal Initiative for Forest and Environment, said, "The basis for negotiations were the three draft resolutions, a joint one by Rwanda-Peru endorsed by 60 countries.... To streamline the process, co-facilitators of the working group cluster, Canada and Ghana, merged texts of Rwanda-Peru and Japan, which became the base document for negotiations..."

The global money laundering and terrorist financing watchdog FATF has retained Pakistan on its terrorism financing "grey list" and asked Islamabad to address at the earliest the remaining deficiencies in its financial system, according to a media report on Saturday.

Pakistan has been on the grey list of the Paris-based Financial Action Task Force (FATF) since June 2018 for failing to check money laundering, leading to terror financing, and was given a plan of action to complete it by October 2019.

Since then, the country continues to be on that list due to its failure to comply

with the FATF mandates.

The plenary on Friday decided against exiting Pakistan from the category despite the country meeting 32 out of 34 action points, the *Dawn* newspaper reported.

#### **Commendable efforts**

However, Pakistan's robust progress on its global commitments to fight financial crimes was appreciated at the concluding session of its hybrid plenary meeting, which noted that Pakistan had completed 26 of the 27 action items in its 2018 action plan of the FATF and of the seven action items of the 2021 action plan of the watchdog's Asia Pacific Group on Money Laundering.

## Mobile World Congress '22 starts in Spain with focus on 5G and economic recovery

G lobal 5G subscriptions are expected to breach the 1 billion mark in 2022 with rapid adoption in key markets, according to the Global Mobile Economy Report released on Monday at the Mobile World Congress in Barcelona, Spain.

"In 2021, mobile technology and services generated \$4.5 trillion in economic value, equating to 5% of global gross domestic product (GDP). This will grow to \$5 trillion in 2025. The report within three years 5G will account for around a quarter of mobile connections, with over two in five people, worldwide, living within the reach of a 5G network.

Focus on 5G and maximizing its potential for benefiting countries was the main theme of this year's event organized by GSMA.

Mats Granryd, director general, GSMA, emphasised the importance of a responsible leadership in investments for global telecom networks--the engines of growth for a postpandemic economic recovery. "Responsible leadership is the way to reject the vision to innovate for global recovery and to unleash the full power of connectivity to transform lives and society," he added.

According to Granryd, the global telecom industry will invest \$600 billion till 2025 in mobile capex and 85% of it will be on 5G.

GSMA said investments in digital skills training, utilising public funds for connectivity, adopting a balanced approach to collecting revenues through taxes and fees in the mobile sector, and prioritising digital transformation in government services, will be key to achieve a resilient post-covid recovery.

4G connections, on the other hand, will account for 55% of the total numbers by 2025, down from its peak of 58% in 2021.

It will have more room to grow in Sub-Saharan Africa, where adoption of 4G is below one-fifth of the total number of connections.

Bharti Enterprises chairman Sunil Bharti Mittal, Amazon Web Services chief executive Adam Selipsky, Federal Communications Commission chairperson Jessica Rosenworcel, and Qualcomm president and chief executive Cristiano Amon are expected to deliver keynote addresses at the Mobile World Congress.

## Ilker Ayci turns down CEO role at Air India

Mumbai, March 1 Îlker Aycı, who was named the CEO of Air India, has declined to take up the assignment. His appointment was announced by the Tata Group on February 14

14. "My appointment at Air India within Tata Group was announced earlier in February, with a start date of April I. Since the announcement, I have been carefully following news in some sections of the Indian media attempting to colour my appointment with undesirable colours," Ayci said in a statement on Tuesday afternoon.

He said that he is a person who has always prioritised professional credo and, importantly, the happiness and well being of his family above all else. "I have come to the conclusion that it would not be a feasible or an honourable decision to accept the position in the shadow of such narrative."

This comes in the wake of reports that the government was not happy with Ayci's appoint-



ment due to his links with the Turkish regime. Turkish President Recep Tayyip Erdogan is a staunch supporter of Pakistan and often stands against India on the International platform. Earlier, Ayci was the Chair-

man of Turkish Airlines. The Tatas had sought the government's approval for Ayci's appointment. Background checks are routine for foreign nationals appointed to key positions in any Indian company. However, the approval has not come through for Ayci.

Industry watchers said that Ayci may have anticipated the scenario of the government rejecting his appointment due to his political connections.

The Tata Group did not offer a comment.

#### Chennai, March 1

The agriculture sector has grown by a CAGR of 11 per cent between 2015 and 2020 with the sector witnessing the highest disruption in terms of smartphone and internet penetration," a report on "Innovation in India's Rural Economy" prepared jointly by the Confederation of Indian Industry (CII) and Bain and Company, has said.

Agriculture is the largest sub-sector in the rural economy, contributing nearly 37 per cent of total rural GDP in 2019-20. Its contribution to the nation's GDP was ₹35-lakh crore, said the report by Parijat Jain, partner of Bain and Company.

Stating that the Indian rural sector is large and growing steadily, it said the rural economy contributed nearly half the nation's overall GDP in 2019-20. Besides, it

provided employment for 350 million people, who made up 68 per cent of the total workforce.

## 10% growth in agri credit

Agriculture credit has grown by 10 per cent in the last five years, from ₹8-lakh crore in 2014-15 to ₹14-lakh crore in 2019-20. Rural microfinance gross loan portfolios also grew, rising from ₹1,32,900 crore in March 2020 to ₹1,46,700 crore in March 2021.

Demand for credit has increased, especially among consumption-driven loan products like those for twowheelers and consumer durables. Technology disruption played a key role in this growth by lowering loan servicing costs, which enabled lenders to service lower-value loans.

All these have resulted in the growth of agtech startups, which attracted ₹6,600 crore as private equity investments between 2017 and 2020. "As newer generations of farmers and FPOs become digitally savvy, new business models are emerging across the agriculture value chain, from inputs and harvesting to processing and distribution," the report said.

The Centre's policies such as formulating a Model Contract Farming Act in 2018 and permitting initiatives by private and non-profit organisations have boosted the setting up and development of farmer producer organisations (FPOs), it said.



iew Delhi, March 2 The new Electronic Bill (ebill) processing system will stop any possible 'rent seeking' in clearance of dues to contractors or suppliers to government departments, Finance Minister Nirmala Sitharaman said here on Wednesday.

The Minister launched the new mechanism while inaugurating the Foundation Day event of the Controller General of Accounts (CGA), the book-keeper of the government.

#### **Digitisation drive**

Sitharaman said the system will ensure end-to-end digitisation and make payment process transparent, by using technology not just within government departthe ments but extending the second leg to the citizens' own use. The e-bill, she said, will shut even "any small window which is available" for misuse in terms of rent seeking" as a contractor or supplier to government will be able to file their claims digitally.

The system will be implemented across all Central ministries and departments, and suppliers and contractors will now be able to submit their claims online that can be tracked real-time. "Put your claim with digital signatures and you do not have to come to government offices. Your payment reaches (to you) as soon your claim reaches with digital signature," Sitharaman said.

#### **Digitally signed bills**

Giving details of the e-bill system, Additional Controller General of Accounts Dharitri Panda said currently the claimants are required to submit physical copies of bills to the departments for scrutiny. With the e-bill initiative, claimants would be able to submit digitally signed bills on the PFMS and check status without approaching offices.

"The system will provide huge convenience to suppliers and contractors. It will have a shorter bill payment cycle, more effective audit trail... It will be an effective tool to facilitate uninterrupted Government disbursements in a pandemic-like situation," she said.

#### **Pilot basis**

With the launch of the e-bill, the system has been rolled out on a pilot basis in eight ministries. It will be implemented in all ministries and departments in a phased manner in 2022-23.

The civil accounts officers, she said, have ensured that the common man who works with the government will not have to wait for months, or meet officials, seeking release of dues.

# NIA set to insure Kudankulam plant with global participation

GIC Re, NIA in talks to sort out the difference in quotes with global reinsurers

#### GEORGE MATHEW MUMBAI, MARCH2

NEW INDIA Assurance (NIA) will soon complete the placement of property cover for units three and four of Kudankulam Nuclear Power Plant (KKNPP), with a sum assured of over Rs 43,000 crore. The cover is likely to be executed with the participation of major global reinsurers, sources said.

NIA, which has provided the property covers for the first two units of the plant with the participation of state-owned GIC Re, has already won the Nuclear Power Corporation of India Ltd (NPCIL) mandate for insuring two more units of the KKNPP after a competitive bidding last November.

The placement of Kudankulam insurance has to be completed soon, as the reinsurance market has shown a hardening tendency in view of the Russian invasion of Ukraine which has started impacting the reinsurance rates, industry officials said.

GIC Re — which has already participated in reinsuring the first two units of KKNPP, not only in terms of mandatory 5 per cent

GIC Re has quoted a higher price of Rs 177 crore for its participation, while NIA has managed a lower quote of Rs 160 crore from a set of international reinsurers located outside India. Going by existing reinsurance norms, in order of preference, NIA has to first approach GIC Re which has the first "right of refusal" for any reinsurance business in India. As phases one and two of the plant have remained claims-free, NIA – India's largest insurer – has managed to get a cheaper reinsurance quote The placement of Kudankulam insurance has to be completed soon, as the reinsurance market has shown a hardening tendency in view of the invasion of Ukraine, which has started impacting reinsurance rates

from international reinsurers.

As per current regulations, once GIC refuses fully or partly, NIA - following the order of preference - can approach foreign reinsurance branches (FRBs) in India, reinsurers who are present in GIFT City (presently only GIC Re) and lastly cross-border reinsurers registered with Irdai. A senior NIA official said. "Currently, senior officials of both GIC Re and NIA are discussing the placement of deal which will mutually benefit them and NPCIL NIA is committed to comply with all reinsurance regulations and safeguarding the interest of NPCIL in terms the best reinsurance cost."

Insurance covers for nuclear plants are purely reinsurance driven, like aviation insurance, where the primary insurer reinsures over 90 per cent of the high value cover with large sum assured, and more than one global reinsurer.

Sources said this is done to ensure that in any case of mishaps, that can trigger large claims, financial compensations are easily mobilised from a clutch of large high net-worth reinsurers which would not be possible in the case of a limited number reinsurers.

NPCIL had mandated NIA among the domestic insurers, which had provided the cheapest bidding in terms of premium, after cancelling the first bidding in 2020. A nuclear plant has two covers: a property cover and a liability cover. The liability cover for a nuclear plant is always covered by the Nuclear Pool, formed by the general insurers and managed by state owned reinsurer GIC Re. While the ground-breaking ceremony for construction of units three and four was performed in February 2016, due to technology changes, inflation and insistence of the supplier and operator for additional liability insurance, construction cost of these additional units has already gone up.

## Govt tweaks rules on bankrupt LLPs

The rules,

he ministry of corporate affairs has amended the limited liability partnership (LLP) rules to address the concerns of entities facing bankruptcy proceedings. The rules, effective 4 March, modified reporting requirements of LLPs in financial distress.

The Limited Liability Partnership (Second Amendment)

Rules 2022 primarily deals with solvency statements and certificate of truthfulness, which are part of the annual returns.

Hence, an LLP's statement of solvency,

which is required to be signed by a designated partner in charge of compliance, can be signed off by a resolution professional in case of a bankrupt entity, it said.

The new rules also cover the requirement of filing a certificate endorsing the truthfulness and correctness of annual returns of LLPs with sales of up

to ₹5 crore, or partner contribution of up to ₹50 lakh.

In normal cases, the certificate is to be signed by a designated partner, other than the one who has signed the annual return. Designated partners have additional responsibility related to compliance requirements of an LLP, compared to other partners. In case of small LLPs facing bankruptcy, the certificate may be signed by a resolution professional or administrator, it

added. The rules outeffective 4 March, lines the administrative changes LLPs undergo

once bankruptcy proceedings are underway and the turnaround professional hired by

lenders to take charge of the affairs of an LLP. Partners or shareholders will remain in control of a business so long as debt is serviced, but after a default, lenders get the upper hand in taking decisions under the Insolvency and Bankruptcy Code, including the right to take over the management and restructure the business.

## Bank of India to launch digital lending platform

Mumbai, March 6 Bank of India (BoI) plans to put in place a mobile-based lending platform to grow its RAM (retail, agriculture and micro, small & medium enterprises) portfolio from about 54 per cent of total domestic loans to 65 per cent in two years.

The bank is developing a tech-stack for enhancing its digital banking presence, according to PR Rajagopal, Executive Director.

He observed that digital lending will help re-balance BoI's portfolio composition towards RAM advances.

"We will launch a super app by Q2 FY23. Vendors have been on-boarded to build the app," Rajagopal said. The app will ensure digitising of loan sourcing, in-principle sanction to customers, and crossselling of non-banking financial services products.



## India added a record 10 GW of solar capacity in 2021

INDIA INSTALLED A record 10 GW of solar capacity in the calendar year 2021, registering a y-o-y rise of 212%, according to Mercom India Research. The country had made 3.2 GW of solar capacity installations during 2020, the research firm said in its latest report. "Solar accounted for 62% of new power capacity additions in 2021, the largest share of power capacity ever," it said. During the year, large-scale solar projects accounted for 83% of installations and saw a 230% y-o-y surge. Rooftop installations registered a y-o-y increase of 138% in 2021. Rajasthan, Karnataka and Andhra Pradesh were the top three states for cumulative large-scale solar capacity, accounting for 50% of the installations in the country as of December 2021. In 2021, Rajasthan led the capacity addition with 4.5 GW of solar capacity installation, the report further said.

this year, seeking directions for a permanent DGP, Mr. Pandey had said that the UPSC committee had ignored his outstanding annual confidential record and left his name out of the empanelment for the post.

His lawyer had told the court that Mr. Pandey is currently the senior-most IPS officer in the State and was appointed the acting DGP last year after the then DGP Subodh Jaiswal was transferred as the chief of the Central Bureau of Investigation.

Mr. Pandey is an alumnus

of IIT Kanpur and worked with Tata Consultancy Service when he left the police force. In 2017, the High Court had granted relief to Mr. Pandey by directing the Department Promotion Committee to consider his promotion and he was later on appointed the acting DGP.

After being rapped by the High Court for non-appointment of a permanent DGP, the Maharashtra government appointed IPS officer Rajnish Seth from the 1988 batch as the DGP on February 18, 2022.

#### **New Chief Secretary**

Meanwhile, following the retirement of State's Chief Secretary Debashish Chakraborty, Additional Chief Secretary (Home) Manukumar Srivastava of 1986-batch of IAS has become the new chief of the State administration.



His record included match figures of 11-152 when West Indies claimed a first-ever Test victory in England at Lord's 72 years ago.





More than 92,000 solar panels in the shape of plum blossoms, floating on the surface of a reservoir in South Korea, offer a vision of how land-scarce developed nations can overcome local resistance to giant renewable-energy projects.

The 17 giant flowers on the 19-kilometer-long (12-mile-long) reservoir in the southern county of Hapcheon are able to generate 41 megawatts, enough to power 20,000 homes, according to Hanwha Solutions Corp., which built the plant.

It's one of the biggest floating-solar plants in the world, and it's in a nation that has been a laggard in adopting renewable energy — even though South Korea's industrialized economy relies heavily on imported fossil fuels. Thailand built the world's largest hydrofloating solar-hybrid system on the Sirindhorn reservoir last year, and Singapore has started a 60-megawatt-peak plant on its Tengeh Reservoir. India plans to complete its huge 600 MW plant above the Omkareshwar dam by 2023.

# Biocon arm to buy Viatris' biosimilars business for \$3.3 bn

#### ENSECONOMIC BUREAU MUMBAI, FEBRUARY 28

BIOCON BIOLOGICS Ltd (BBL), a subsidiary of Biocon Ltd, on Monday said it will acquire Viatris Inc's biosimilars business in a \$3,3 billion cash-and-stock deal.

US-based Viatris will receive cash consideration of \$2 billion on closing of the transaction and up to \$335 million as additional payments expected to be paid in 2024. Additionally, after the closure of the transaction, BBL will issue \$1 billion of compulsorily convertible preference shares (CCPS) to Viatris, equivalent to an equity stake of at least 12.9 per cent in the company, on a fully diluted basis.

The transaction is expected to close in the second half of 2022, subject to satisfaction of closing conditions (including certain regulatory approvals). Biocon shares fell 11.47 per cent to Rs 348.95 on the BSE on Monday.

Kiran Mazumdar-Shaw, executive chairperson, Biocon Biologics, said: "This acquisition is transformational and will create a unique fully integrated, world leading biosimilars enterprise. Our global partnership with Viatris has enabled us to achieve many firsts."

# World's largest plane, Ukraine's Mriya, destroyed by Russia strikes

**Kyiv:** The largest plane in the world — Ukraine's Antonov-225 cargo plane — was destroyed by Russian strikes at the Antonov airport in Gostomel near Kyiv on the fourth day of Moscow's invasion, Ukraine's state-owned Ukroboronprom group said on Sunday.

The aircraft was unique to the world, at 84m-long (276ft) it could transport up to 250 tonnes of cargo at a speed of up to 850kmph. It had been named "Mriya" — "dream" in Ukrainian. Ukroboronprom estimated that restoring the "Mriya" would cost over \$3 billion and could take over five years. Initially built as part of Soviet aeronautical programme, An-225 made its first flight in 1988. AFP

# IAF decides to postpone Ex Vayu Shakti 2022

The Indian Air Force (IAF) has decided to postpone its firepower demonstration, Ex Vayu Shakti, scheduled in the Pokhran ranges in Rajasthan on March 7 "due to the developing situation", sources in the Air Force said on Saturday.

"Fresh dates shall be intimated subsequently," said an IAF source.

Amid the deepening crisis in Ukraine, on Friday, the Defence Ministry announced that the 12th edition of the biennial DefExpo to be held in Gujarat for the first time has also been postponed "due to logistics problems being experienced by participants."

The triennial Ex Vayu Shakti 2022, aimed at showcasing the capability of the IAF to conduct full spectrum operations, was to see the participation of 148 aircraft and helicopters, including 109 fighter aircraft, 24 helicopters, seven transport aircraft and four unmanned aerial vehicles.

The frontline aircraft in the IAF inventory, including the Russian SU-30MKI and MiG-29UPG fighters, the latest induction from France, the Rafale, as well as the Mirage 2000, the U.S.-origin C-130 and C-17 transport aircraft, AH-64E Apache attack helicopters and CH-47F Chiook heavy-lift helicopters, the indigenous Light Combat Aircraft, Advanced Light Helicopter and the Light Combat Helicopter, were to demonstrate their capabilities at Vayu Shakti.

# Locally made trainer aircraft finishes sea trials

HANSA-NG is reportedly one of the most advanced trainers

### JACOB KOSHY

A first-of-its-kind indigenous aircraft trainer, HANSA-NG, developed by the CSIR-National Aerospace Laboratories (CSIR-NAL), has completed sea-level trials in Puducherry, a necessary condition before evaluation by the Directorate General of Civil Aviation (DGCA).

HANSA-New Generation is reportedly one of the most advanced flying trainers, powered by a Rotax digital control engine with features such as a composite lightweight airframe, a glass cockpit, a bubble canopy with a wide panoramic view, and electrically operated flaps.

The CSIR-NAL says the aircraft is designed to meet the need of flying clubs in India for trainer aircraft.

"It is an ideal aircraft for commercial pilot licensing due to its low cost and low fuel consumption. NAL has already received more than 80 nos. of LoIs [letters of intent] from various flying clubs," the organisation said in a statement.

The aircraft had so far completed 37 flights and 50

hours of flying and a few more were necessary before getting "type certification" by the DGCA. This certification process is likely to be completed by April and thereafter, industry will begin to manufacture the aircraft.


#### Cruise to Puducherry

For the sea trials, the aircraft was flown from Bengaluru to Puducherry covering 140 nautical miles in an hour and a half at a cruising speed of 155 kmph on February 19. The objectives were to evaluate handling qualities, climb and cruise performance, baulked landing and structural performance, including positive and negative G-forces, and power plant and other systems performance.

CSIR-NAL said in a statement that "all the objectives of the sea-level trials are met", and the aircraft was being ferried back to Bangalore, the headquarters of the CSIR-NAL.

The two-seater Hansa-NG, a revamped version of the original Hansa developed three decades ago, had a successful maiden flight on September 4 when it took off from the HAL airport in Bengaluru and flew for about 20 minutes.

The CSIR-NAL has said the aircraft will be certified within the next four months before it gets inducted into service.



## Matsya Setu 2.0 to boost freshwater fisheries

#### SANDIP DAS New Delhi, March 6

IN AN INITIATIVE to bring inland fisheries trade under a single digital platform, the government will soon launch a mobile app whereby farmers, wholesale buyers, suppliers of feed and equipment and other members of the value chain will be able to share information on market prices and availability of produce.

Matsya Setu 2.0, an android mobile app developed by ICAR-Central Institute of Freshwater Aquaculture (CIFA), Bhubaneswar, with funding from the National Fisheries Development Board, Hyderabad, has features to facilitate trade in freshwater fisheries based on geographical location of the stakeholders.

"This app focuses on freshwater fisheries trade, where aqua farmers get access to price information and availability of suppliers based on geographical locations," Saroj Kumar Swain, director, CIFA, told FE. The app is likely to be formally launched next month and will cater to the B2B (business-to-business) segment of the trade.



Currently, information about prevailing wholesale prices of freshwater fish is scattered and patchy. Matsya Setu 2.0 will help farmers with real-time information on prices. India's fish production was 14.2 million tonne in 2019-20. Inland fisheries have a 74% share of total fish production, while the rest is contributed by marine fisheries. The app will also have online courses,

The app will also have online courses, wherein experts on aquaculture demonstrate breeding, seed production and information about commercially important fish like carp, catfish, scampi, murrel, ornamental fish and pearl farming.

Ilike carp, catfish, scampi, murrel, ornamental fish and pearl farming. It will be an upgraded version of the Matsya Setu app launched in July 2021, which provided freshwater aquaculture technologies to farmers. In the first version of the app, information about management practices to be followed in maintaining soil and water quality, feeding and health management in aquaculture operations was provided.

An official said the fisheries sector is considered a 'sunrise sector' and has witnessed average annual growth of 10.87% since 2014-15. "There has been a definitive shift in fish production from marine fisheries to inland fisheries, primarily because of rapid growth of inland aquaculture," the official said.

The Pradhan Mantri Matsya Sampada Yojana, a scheme to bring about the 'blue revolution' is being implemented from 2020-21 to 2024-25, with an investment of ₹20,050 crore. The Centre has allocated ₹1,879 crore towards the scheme in 2022-23, while ₹1,200 crore was allocated under revised estimates in 2020-21.

India is the second-largest fish producing country in the world, accounting for 7.56% of global production in 2020. The sector contributed about 1.24% to the country's gross value added (GVA) and over 7.28% to the agricultural GVA in 2020-21.

# New gin berry species discovered in T.N.

### *Glycosmis albicarpa* bears distinct large white fruit

A team of scientists from the Botanical Survey of India (BSI) have discovered a new gin berry species from the Kanyakumari Wildlife Sanctuary in Tamil Nadu. The species, *Glycosmis albicarpa*, with a distinct large white fruit, is endemic to the

southern Western Ghats. The species belongs to the Orange family *Rutaceae*. The findings have been

published in the latest issue of the Nordic Journal of Botany published from Sweden.

Many of the related plants of these taxonomic groups

are being utilised for their medicinal values and food. Most commonly related species of these plants are collected from the wild, mainly for local use as food and medicine.

Berries of the *Glycosmis* species have the unique characteristic of 'gin aroma' and gained in popularity as an edible fruit. The species is al-

so a larval host plant for butterflies like other species of *Glycosmis*, said K.A. Sujana, the leader of the scientific team.

The species, an evergreen small tree, was found as undergrowth in the Tirunelveli semi-evergreen forests at the Panagudi forest section of the wildlife sanctuary as a single population that covers an area of approximately 2 sq. km., said Dr. Sujana.

'While exploring the study site, four sub-populations of the species were located in the valley between two hillocks, with each having three-seven mature individuals in groups," she said. Though flowering, natural regeneration and seedling recruitment of this taxon is found to be fairly good within the locality, habitat modification causes a major threat to the survival of this species, she added. "A special conservation effort for this particular region is the need of the hour," said Dr. Sujana.

The discovery not only reemphasises the uniqueness and endemism in Western Ghats' flora but also add to the growing inventory of the region's flora, said Ragesh Gopala Vadhyar, co-author.
