# 'CBDT aims to lift tax-GDP ratio to 15-20% from the current 12%'

India logs record net direct tax revenue in FY22: Mohapatra

India's net direct tax collections amounted to ₹14,09,640.83 crore for FY22, which is the highest collection ever, signaling that the Indian economy has bounced back after two years of the pandemic, Central Board of Direct Taxes (CBDT) Chairman J.B. Mohapatra said here on Tuesday.

"As against ₹14.09 lakh crore this year, our collection in 2020-21 was only ₹9.45 lakh crore. In a single year, we moved upward by nearly ₹4.5 lakh crore, registering a growth of 49%," said Mr. Mohapatra, addressing a press conference.

"The collection... is the

best-ever... as far as income tax and corporation tax are concerned."

Gross direct tax collections (before adjusting for refunds) grew 32.8% to ₹16,34,454.95 crore in FY22 compared with ₹12,31,270.52 crore in FY21.

"Increase in net and gross collection numbers is a ma-

ior indication of the strengthening of the Indian economy. This gives the clearest signal that the Indian economy has bounced back after two pandemic years," Mr. Mohapatra said.

### '60% of overall tax take'

"The direct tax-to-GDP ratio is around 12%," he added, noting that the CBDT was working to raise the ratio to 15-20% in 5-10 years.

"The direct tax collection this year has surpassed the indirect tax collection which was other way round till last year. It is now 52%... our aim is to look at 60% of tax contribution coming from direct taxes in some years," said the CBDT chairman.

# Tata Steel Q4 net rises 37% to ₹9,835 cr.

Steelmaker announces 10:1 stock split, board also recommends a dividend of ₹51 per share

Tata Steel Ltd. reported fourth-quarter consolidated net profit rose 37% to ₹9,835 crore helped by a jump in sales on 'higher prices in Europe and higher deliveries in India and Europe'.

Revenue for the quarter ended March, increased by almost 39% to ₹69,324 crore.

For the full year, profit surged fivefold to ₹41,749 crore, as revenue climbed 56% to ₹2,43,959 crore.

"Tata Steel has again demonstrated its ability to deliver stellar results despite heightened complexity in the face of COVID as well as geopolitical tensions," CEO & MD TV. Narendran said on a conference call. "Our Indian business showed broad based growth across our chosen segments due to our

sustained focus on customer relationships, our distribution network and our portfolio of brands supported by our agile business model. Our European operations delivered robust performance as the transformation programme undertaken helped to leverage the strong

business environment," he added.

The company said net debt declined to ₹51,049 crore, adding that it would continue to cut debt going forward despite higher capital allocation.

Tata Steel's board recommended a dividend of ₹51

per fully paid equity share and ₹12.75 per partly paid-up equity share. It also proposed a 10:1 stock split with each share split into 10 with face value of ₹1 each.

The company said annual crude steel output had hit a record 19.06 million tons last fiscal, a growth of 13%.

### 'Strong momentum'

Providing its outlook for the first quarter, Tata Steel said it sees 'strong underlying momentum despite short-term volatility' with the Russia-Ukraine war and energy costs posing risks.

Mr. Narendran said the company had pursued several initiatives to de-risk the business particularly across its supply chain. "We... continue to invest in technology and digitisation to drive productivity and improve our

resilience," he said, adding that the Kalinganagar expansion was progressing well and would help drive cost savings as well as product mix enrichment.

"We have closed the financial year with consistent and record operating and financial performance despite the significant surge in international coal prices and inflationary impact of various commodities," observed ED & CFO Koushik Chatterjee.

"We continue to focus on deleveraging while advancing on our strategic growth priorities – our focus is on completion of the Kalinganagar expansion," he said, adding the company had a capital allocation plan of ₹12,000 crore for FY23 and this figure could likely be scaled up in the middle of the year.

# Telcos urge big cut in 5G spectrum price, cite viability

Will take at least 5 years for profits on 5G investments: COAI

The Cellular Operators Association of India is pitching for a 'significant' reduction in 5G spectrum prices recommended by sectoral regulator TRAI to ensure a 'viable business' case. The association flagged that it would take the telecom industry at least five years to realise profits on the huge investments that would go into 5G roll-outs.

"The prices for 5G spectrum will be determined by demand and supply, and currently there is really no viable business case for 5G," COAI director-general S.P. Kochhar said.

Pointing out that even developed countries, where 5G

had been introduced, were expecting maximum revenue to come from enterprise customers. However, that had not happened and only about 10-15% revenues were coming from enterprises.

"We will have to invest huge amounts in spectrum, in radios and in networks, ...

with profits being seen maybe 5-6 years down the line... It should be a viable business case that we get spectrum at an affordable cost that does not make us bankrupt or make all our money go down the drain till the time the anticipated use case comes, if at all it comes," he explained.

He stressed that the government would not lose out overall because up till 4G, it was getting revenue from spectrum and taxes on consumer tariffs. Now, all industries were going to ride on 5G; their output capacity and profit margins will rise and hence, their contribution via taxes to the exchequer was going to increase massively, he pointed out.

# Flawless Leclerc scorches Albert Park circuit

Red Bull's Perez is second; Verstappen fails to finish

A flawless Charles Leclerc led from start to finish to steer his Ferrari to an action-packed win at the Australian Grand Prix on Sunday with World champion Max Verstappen failing to finish.

The World championship leader from Monaco started from pole, held his position at the first turn and never looked back, scorching round the 58-lap Albert Park circuit to take the chequered flag by a massive 20.5 seconds.

#### Hamilton fourth

Red Bull's Sergio Perez was second with George Russell an encouraging third for the struggling Mercedes and his seven-time World champion teammate Lewis Hamilton fourth.

The McLaren's of Lando Norris and Daniel Ricciardo were fifth and sixth.

Alpine's Esteban Ocon came seventh ahead of Valtteri Bottas in an Alfa Romeo, with Pierre Gasly's AlphaTauri and Alex Albon's Williams rounding out the top 10.

But there was disaster for Red Bull's Verstappen, the winner two weeks ago in Saudi Arabia, who pulled over on lap 39 when second, saying on the team radio: "I smell some weird fluid."

He jumped out with smoke coming from the engine, grabbing a fire extinguisher to help marshals put out the flames.

It was his second retirement in three starts this season.

In contrast, Russell was delighted with his podium place after Mercedes' early-season struggles with porpoising – bouncing at high speed.

**R**iya Bhatia and Ankita Raina won their singles matches to help India beat Korea 2-1 and finish third in the Asia-Oceania Billie Jean King Cup women's tennis tournament in Antalya, Turkey.

**USE OF NOUNS AS THE DIRECT OBJECT:** An object is the person or thing that receives the action of the verb. It is the who or what that the subject does something to. Now, there are two types of Objects i.e. 'Direct' and 'Indirect' object. Direct object is the thing being acted upon i.e. the receiver of the action. A direct object answers the question 'what' or 'whom.' Finding the direct object is simple if we identify the subject and verb in a sentence.

Examples:

The engineer built a marvelous house.

(Here, engineer is the subject and built is the verb. Now, the answer to the question 'what did the engineer built?' is house. Therefore house is the direct object.)
