J&K forms panel for G20 meetings in 2023

EXPRESS NEWS SERVICE SRINAGAR, JUNE 24

THE JAMMU and Kashmir administration has constituted an overall coordination committee for meetings to be held in 2023, as India assumes the presidency of the G20.

The committee will be chaired by the UT's Principal Secretary, Housing & Urban Development Department with Commissioner/Secretary, Transport Department, Administrative Secretary, Tourism Department, Administrative Secretary, Hospitality & Protocol Department, and Administrative Secretary, Culture Department, as its members.

The Principal Secretary to the government, Housing & UD, will also be the UT-level nodal officer to coordinate the arrangements for G20 meetings next year.

With the cancellation of the GST council meetings that were scheduled to be held in Kashmir, this month being moved to Chandigarh, last minute, the G20 meetings are likely to be J&K's first major event since the revocation of the former state's special status in 2019.

As a Troika-member, India is working closely with Indonesia and Italy to ensure consistency and further strengthening the G20 agenda. India will assume the G20 Presidency on December 1, 2022, from Indonesia, and will convene the G20 Leaders' Summit for the first time in India in 2023, as per the Ministry of External Affairs.

In September 2021, Commerce and Industry Minister Piyush Goyal was appointed as India's Sherpa for the G20.

Bhubaneswar service, recipient of UN Public Service Award

MO BUS, the bus service of Odisha's Capital Region Urban Transport (CRUT) authority, has been recognised by the United Nations as one of 10 global recipients of its annual Public Service Awards for 2022, it was reported on Wednesday. It has been recognised for its role in "promoting gender-responsive public services to achieve the SDGs (Sustainable Development Goals)".

The UN recognition noted that the Odisha government in 2018 "reorganised the public transit services in the city to provide an integrated, reliable and inclusive public bus service system". Mo Bus has incorporated "real-time technologies like live tracking, travel planner and e-ticketing", and an e-rickshaw system (MoE-Ride) has been introduced as a feeder service.

The "impact" is that 57% of the city's commuters now use the Mo Bus, the UN said. Mo E-Ride is estimated to reduce pollution by 30-50%. Also, "40 per cent of Mo



The UN recognition is for promoting 'gender-responsive public services'.

Bus conductors are women and 100 percent of Mo E-Ride drivers are women, transgender people, and people from disadvantaged communities," the UN noted.

According to the CRUT website, it plans to introduce 289 buses in three phases, and to extend the service to Cuttack soon.

Gadkari approves draft car-safety scheme

Country to have its own star ratings

SPECIAL CORRESPONDENT

Minister for Road Transport and Highways Nitin Gadkari on Thursday approved a draft notification that paves the way for the country to have its own crash-linked safety performance star rating system for cars.

The five star-rating system under the Bharat New Car Assessment Programme (Bharat - NCAP) would assign cars between one to five stars based on how well they perform in crash tests with zero star indicating lowest safety standards.

The overall assessment is based on the vehicle's performance under three categories – adult, child-occupant protection and safety-assist technologies.

The assessment would be conducted at a higher crash -test speed of 64 kmph compared with 56 kmph required for type rating. The scheme is not mandatory for manufacturers and models would be selected on the basis of their popularity.

When a vehicle is selected based on its popular the base model would be 14/12 lected and tested for rating.

Bharat NCAP to be rolled out from April 1 next year

THE NEW CAR safety assessment programme, Bharat New Car Assessment Programme (Bharat NCAP), which proposes a mechanism of awarding 'star ratings' to automobiles based upon their performance in crash tests, will be rolled out from April 1, 2023, an official statement said on Saturday.

According to the statement, Bharat NCAP is applicable on type approved motorvehicles of category M1 (motorvehicles used for the carriage of passengers, comprising eight seats, in addition to driver's seat) with gross vehicle weight less than 3.5 tonne, manufactured or imported in the country.

The standard is aligned with global benchmarks and it is beyond minimum regulatory requirements.

The rating will provide consumers an indication of the level of protection offered to occupants by evaluating the vehicle in the areas of—adult occupant protection, child occupant protection and safety assist technologies, the statement said. — PTI

Govt to move NDPS admn to MHA

NEW DELHI, JUNE 24 The government is considered a move to transfer the administration of the two laws — Narcotic Drugs and Psychotropic Substances Act (NDPS), 1985 and Prevention of Illicit Traffic in Narcotic Drugs and Psychotropic Substances Act, 1988 — from the Finance Ministry to the Union Ministry of Home Affairs (MHA), sources said.

The sources said the move was intended to bring all issues related to narcotics under one department, as currently while the Narcotics Control Bureau (NCB) is under the administrative control of the MHA, the Department of Revenue (DoR) in the Finance Ministry administers the two anti-drug laws. — TNS

- At present, the Home Ministry governs the Narcotics Control Bureau so the government is planning to bring all issues related to narcotics under the Ministry of Home Affairs.
- Narcotic Drugs and Psychotropic Substances Act, 1985 prohibit a person from the production/manufacturing/cultivation, and consumption of any narcotic drug.

AS INDIA entered the pandemic year, students in around 61 per year, students in around 61 per cent districts of the country had very little exposure to digital learning due to limited availabil-ityof computers, Internet facilities and teachers trained to handle technological tools in schools, ac-cording to a Ministry of Education report released on Monday. The Performance Grading Index for Districts (PCI-D) for

Index for Districts (PGI-D) for 2019-20 shows that schools 2019-20 shows that schools acrossindia performed poorly un-der the category of digital learn-ing, which threw up the lowest scores compared to the other pa-rameters which were considered while creating the index. In the index, as many as 180 districts scored less than 10 per cent on digital learning, 146 dis-tricts scored 11 to 20 per cent

tricts scored 11 to 20 per cent. while 125 districts had scores

while 125 districts had scores between 21 and 30 per cent. The report also underlines the clear rural-urban divide in the area of digital learning. For instance, while districts in cities like Chandigarh and Delhiscored heatureng 25 and 25 cut of 50. between 25 and 35 out of 50, places like Bihar's Araria and Kishanganj scored as low as 2. Backward districts like sam's South Salmara-

Backward districts like Assam's South Salmara-Mankachar and Tripura's Dhalai scored 1. The district-wise per-formance on digital learning was drawn up based on the number of schools with computers/lap-tops. Internet facility, student-to-computer relies and presentation computer ratio and percentage of teachers trained to use and

of reachers trained to use and teach through computers. In contrast, in terms of learn-ing outcomes, no district scored below 10 per cent, 12 scored be-tween 11 and 20 per cent, while as many as 309 scored between 51 and 60 per cent.

- The Department of School Education and Literacy (DoSE&L), Ministry of Education today released the Performance Grading Index for Districts (PGI-D) for 2018-19 and 2019-20which assesses the performance of the school education system at the District level by creating an index for comprehensive analysis.
- The Indian Education System is one of the largest in the world with about 15 lakh schools, 97 lakh teachers, and nearly 26crore students from varied socioeconomic backgrounds.
- The PGI-D structure comprises of total weightage of 600 points across 83 indicators, which are grouped under 6 categories viz., Outcomes, Effective Classroom Transaction, Infrastructure Facilities & Student's Entitlements, School Safety & Child Protection, Digital Learning and Governance Process.
- These categories are further divided into 12 domains, viz., Learning Outcomes and Quality (LO), Access Outcomes (AO), Teacher Availability and Professional Development Outcomes (TAPDO), Learning Management (LM), Learning Enrichment Activities (LEA), Infrastructure, Facilities, Student Entitlements (IF&SE), School Safety and Child Protection (SS&CP), Digital Learning (DL), Funds convergence and utilization (FCV), Enhancing CRCs Performance (CRCP), Attendance Monitoring Systems (AMS) and School Leadership Development (SLD).
- PGI-D grades the districts into ten grades viz., Highest achievable Grade is Daksh, which is for Districts scoring more than 90% of the total points in that category or overall.
- The lowest grade in PGI-D is called Akanshi-3 which is for scores upto10% of the total points.
- The ultimate objective of PGI-D is to help the districts prioritize areas for intervention in school education and thus improve to reach the highest grade.







MoD approves 'BRO cafes' in border areas

The Ministry of Defence on Wednesday approved the setting up of wayside amenities with the Border Roads Organisation (BRO), to be branded as 'BRO Cafes', at 75 locations in 12 States and Union Territories on different sections of roads.

"These are intended to provide basic amenities and comfort to tourists and lead to boosting of economic activities in border areas, besides generating employment for the local people," the Ministry said in a statement.

The scheme provides for wayside amenities in public-private partnership mode with agencies, on a licence basis, which will design, build and operate the facility as per guidelines of the BRO. Proposed amenities include parking for two and four wheelers, food plaza, restaurant, separate rest rooms for men. women and differently abled, and first aid facilities, among others. Selection of licences will be done through a competitive process, the Ministry said.

To provide comfortable transit of tourists on these roads, located at harsh climatic conditions, the need to establish multi-utility wayside amenities was recognised, it said.

President Joe Biden on Saturday signed the most sweeping gun violence Bill in decades, a bipartisan compromise that seemed unimaginable until a recent series of mass shootings, including the massacre of 19 students and two teachers at a Texas elementary school.

"Time is of the essence. Lives will be saved," he said. Citing the families of shooting victims, the President said, "Their message to us was, 'Do something.' How many times did we hear that? Just do something. For God's sake, just do someth-

ing.' Today we did."

The House gave final approval on Friday, following Senate passage on Thursday, and Mr. Biden acted just before leaving Washington for two summits in Europe.

"Today we say, 'More than enough,'" Mr. Biden said. "It's time, when it seems impossible to get anything done in Washington, we are doing something consequential."

The legislation will toughen background checks for the youngest gun buyers, keep firearms from more domestic violence offenders and help States put in place "red flag" laws that make it easier for authorities to take weapons from people adjudged to be dangerous.

The President called it "a historic achievement."

Most of its \$13 billion cost will help bolster mental health programmes and aid schools, which have been targeted in mass shootings.

BRICS summit: Xi criticises 'abuse' of sanctions, Putin scolds the West

CHINESE PRESIDENT XI Jinping on Thursday criticised⁴ the abuse⁶ of international sanctions, while Russian President Vladimir Putin scolded the West for fomenting global crisis, with both leaders calling for greater BRICS cooperation. Xi called on Brazil, Russia, India, China

Xi called on Brazil, Russia, India, China and South Africa (BRICS) to take up the responsibility conferred by their economic clout, and said they should stand up for a truly multinational international system based on the United Nations.

"We must abandon Cold War mentality and block confrontation and oppose unilateral sanctions — and the abuse of sanctions," Xi told the BRICS summit through a translator.

"Our meeting today comes at a crucial moment of choice for the future of humanity: as key emerging markets and developing countries, BRICS countries must rise to our responsibility." Xi said.

must rise to our responsibility," Xi said. China has by far the largest economy in the BRICS grouping, accounting for more than 70% of the group's collective \$27.5 trillion economic might. Putin called for stronger BRICS cooper-

Putin called for stronger BRICS cooperation and accused the West of fomenting a crisis. "Only on the basis of honest and mutually beneficial cooperation can we look forways out of the crisis situation that has developed in the global economy due to the ill-considered and selfish actions of individual states," Putin said. He accused the West of "using financial

He accused the West of "using financial mechanisms" to "shunt their own mistakes in macroeconomic policy on to the whole world". Putin has said relations with China are the best they have everbeen and touts a strategic partnership with China aimed at countering US influence.

Big industries will be charged 10% 'super tax': Pak PM

ISLAMABAD: Pakistan Prime Minister Shehbaz Sharif on Friday announced a 10% "super tax" on large-scale industries like cement, steel and automobiles, a move he said was aimed at tackling spiralling inflation and saving the cash-strapped country from going "bankrupt".

High net worth individuals will also be subject to a "poverty alleviation tax", Sharif announced after chairing a meeting of his economic team on the federal budget for the next fiscal year 2022-23.

"Our first motive is to provide relief to the masses and to reduce the burden of inflation on the people and facilitate them," Sharif said in a video message to the nation.

"Our second motive is to protect the country from going bankrupt," he said, adding that it has been devastated due to the "incompetency and corruption" of the previous Imran Khan-led government.

The sectors on which this

"super tax" will be levied include cement, steel, sugar, oil and gas, fertilisers, LNG terminals, textile, banking, automobile, cigarettes, beverages and chemicals, he said.

Sharif explained that other motives included stabilisation of the economy.

"These aren't just words, this is the voice of my heart and InshaAllah we will be able to achieve all these targets," he said. He said history had witnessed that in difficult times, it was the poor people who always made sacrifices.

"Today, it is time for the affluent citizens to do their part. It is their turn to show selflessness. And I am confident that they will contribute fully to play their part," Sharif said.

He said the institutions whose job is to collect tax should take from the rich and give to the poor.

Those whose annual income exceeds Rs 150 million will be subject to 1% tax; for Rs 200 million, 2%; Rs 250 million 3%; and Rs 300 million will be taxed 4%of their income, he said.

Mumbai is the most expensive Indian city for expatriates, according to Mercer's 2022 Cost of Living survey.

Globally, the city ranks 127, down from 78 last year. However, it is the most costly city in India in terms of both living expenses and accommodation, as per the report. It is followed by New Delhi (155), Chennai (177), Bengaluru (178), and Hyderabad (192), while Pune (201) and Kolkata (203) are the least expensive Indian cities in the ranking.

The survey was conducted in March 2022. The ranking compares the prices of over 200 commodities, including housing, transportation, food, clothing, household goods and entertainment in 227 cities across five continents. Mercer revamped its methodology this

year with new items such as smartwatches, tablet computers and smartphones added to the 'çost of living' list, while items such as music CDs and video movie rentals were removed.

As per the study, Kolkata has the lowest cost of daily necessities such as milk, breads, vegetables, and so on, while it is the highest in Mumbai and New Delhi.

Cost of home utilities such as energy and phone is the highest in Mumbai and lowest in Chennai and Hyderabad. Mumbai is also the most expensive for movie watching, while Hyderabad is the cheapest.

Global mobility

Hyderabad was also the cheapest in terms of housing, but is more expensive than Pune and Kolkata when cost of living and housing are both



taken into account. Mumbai has the most costly rentals, foilowed by New Delhi and Bengaluru. Accommodation in other Indian cities in the ranking(Chennai, Hyderabad, Pune, Kolkata) is over 50 per cent cheaper than in Mumbai.

Rahul Sharma, India Mobility Leader, Mercer, said, "Global supply chains for necessities have been disrupted as a result of Covid-19-related volatility, which has been exacerbated by the conflict between Ukraine and Russia.

Talent mobility

Additionally, we have seen that petrol costs have increased in all Indian cities. Also, the price of a new car and other maintenance costs have gone up in all Indian cities." The report added that it is imperative to re-examine and reinvent talent mobility programmes in the current global environment, given the challenges of cost and the complexity of operating.

Compared to other major cities in the Asia-Pacific region like Beijing, Shanghai and Manila — Mumbai and New Delhi have a lower cost of living and expat accommodation.

The survey also found that Mumbai is a popular place for multinational corporations to establish operations. "Organisations are, however, also considering other low-cost areas such as Hyderabad, Chennai, and Pune due to the greater cost of living in Mumbai," it added.

Four out of the 10 most expensive cities to live in for international assignees are in Asia, including the most expensive globally – Hong Kong. Singapore (8), Tokyo (9) and Beijing (10) are among the others in the top 10 list.

The Cost of the Living survey was conducted in March 2022. This year's ranking compares the prices of more than 200 commodities including housing, transportation, food, clothing, household goods, and entertainment in 227 cities spread across five continents.

"The underlying principle of rethese Directions is that the RE should ensure that outsourcing A, us arrangements neither diminish its ability to fulfil its obligations on to customers nor impede effecry er tive supervision by the supervising authority," said the draft, iron which the RBI has invited ur comments from stakeholders by July 22. ed

Banks, payment banks, of cooperative banks, credit infornd mation companies, NBFCs and ld other regulated entities, would nk be required to put in place a TIcomprehensive boardapproved IT outsourcing policy. "Outsourcing of any activity of the RE shall not diminish its obligations as also of its Board and senior management, who shall be ultimately responsible for the outsourced activity.

"RE shall take steps to ensure that the service provider employs the same high standard of care in performing the services as would have been employed by the RE if the same activity was not outsourced," the draft said.

The draft specifies the role of the board and senior management, besides norms pertaining to the usage of cloud computing services and outsourcing of the Security Operations Center (SOC).

The RBI has also proposed that the REs should set up a robust grievance redressal mechanism, "which in no way shall be compromised on account of outsourcing", meaning responsibility for redressal of customers' grievances related to outsourced services would rest with them.

As per the draft, a risk

management framework for the outsourcing of IT services should comprehensively deal with the processes and responsibilities for the identification, measurement, mitigation/ management and reporting of risks associated with outsourcing.

Entities regulated by the RBI should also require their service providers to develop and establish a robust framework for documenting, maintaining and testing Business Continuity Plan (BCP) and Disaster Recovery Plan (DRP)

Also, a RE could outsource any IT activity/IT-enabled service within its business group/ conglomerate, provided that such an arrangement is backed by the Board-approved policy and appropriate service level arrangements/ agreements with its group entities are in place, the draft said.

It has also proposed additional requirements for crossborder outsourcing.In February this year, the RBI had proposed to issue a guideline on outsourcing.

According to the draft, the risk management framework for the outsourcing of IT services will have to deal with the identification, measurement, mitigation/ management, and reporting of risks associated with outsourcing.

Sitharaman told the press that the Council took up reports by the four Groups of Ministers. 

GST rate shakeup: Rise, fall, and exemptions gone

The GST Council on Wednesday recommended several changes to tax rates, including correction of inverted duty structure and withdrawal of certain exemptions. GST was exempted on specified food items, grains etc when not branded, or right on the brand has been foregone. Now, it has recommended withdrawal of exemption from pre-packaged and pre-labelled retail pack in terms of Legal Metrology Act, which will include pre-packed, pre-labelled food items like curd, lassi, puffed rice, wheat flour, paneer, and butter milk

GST RATE INCREASED FROM 12% TO 18%:



- There will be no refund of accumulated input tax credit (ITC) on goods such as edible oil and coal. Exemptions have also been withdrawn for room rents.
- 12% GST will now be collected on hotel rooms having rent up to Rs 1,000 a day.
- 5% GST will be collected on hospital room rent above Rs 5,000 per day (excluding ICU).
- GST rate has been reduced for ostomy/orthopedic appliances from 12% to 5%.
- GST rate has been reduced for transport of goods and passengers by ropeways from 18% to 5% with an input tax credit. These rate changes will be effective July 18.
- The GoM headed by Karnataka Chief Minister BasavarajBommai has received a 3-month extension for rate rationalization measures.

- Presently, online gaming has a dual-rate of taxation- 18% on games of skill (not involving betting or gambling) and 28% on games of chance (involving betting and gambling).
- Online gaming apps pay GST at 18%. Casinos and horse racing attract a GST of 28%.
- The GoM recommended a uniform 28% GST rate on horse racing, online gaming, and casinos.
- The GoM had recommended that online gaming should be taxed at the full value of the consideration and no distinction be made on grounds of the game of skill or game of chance for the levy of GST.

SBI gets RBI nod to set up operations support arm

Will help improve cost-to-income ratio, says Chairman

Mumbai, June 26 State Bank of India has received in-principle approval from the Reserve Bank of India for its proposed operations support subsidiary aimed at bringing down the cost-to-income ratio. The bank will soon start a pilot run in a few regions before launching the new subsidiary pan India.

"We are setting up an operations support subsidiary. It is intended to address the concern relating to the costto-income ratio. We have already got the in-principle approval from RBI and soon we will be launching it in a pilot mode," said SBI Chairman Dinesh Kumar Khara.

Bettering efficiencies In an interaction with BusinessLine, Khara said the subsidiary will enable the lender to leverage its high cost manpower for more productive services. SBI's cost-to-in-

come ratio stood at 53.3 per cent in FV22, an improvement of 240 basis points over FY19 levels. In comparison, the cost-to-income ratio of top three private banks are well below SBI's, at 35-40 per cent. Therefore, the subsidiary, aimed at bettering the operating efficiencies, can help India's largest bank significantly improve its profitability over time. In FY22, SBI's net interest margin stood at 3.15 per cent, while the average for private banks topped 4 per cent in FY22.

"Routine jobs can be done by the subsidiary. We are finalising the structure but it



will be more technology and some people. Technology supporting people on ground," he said, adding that core functions such as the loan sanctioning process will remain within the bank.

"Core functions cannot be outsourced, as per RBI directions," he pointed out.

Khara said the pilot will be launched soon within a quarter or so in a few circles and once the results are seen, it would be rolled out across the country.

Terming it one of his pet projects, Khara said that the bank had in January this year initiated the process of hiring a consultant to set up an operations support subsidiary.

Focus areas

The subsidiary would focus on providing support services mainly for agriculture, micro, small and medium enterprises, other micro loans, data entry operations, activities that can be undertaken as allowed for Business Correspondents, among others.

SBI has been working to improve its cost efficiencies. The cost-to-income ratio has declined to 53.31 per cent in 2021-22 from 53.5 per cent in 2020-21 and 55.7 per cent in 2018-19.

Not many lenders in the public sector operate with a subsidiary to handle the bank's non-core functions, while the model is quite popular with private banks. Among public sector banks, Bank of Baroda was the first to undertake a similar strategy of operations support. However, Khara believes that given SBI's scale and size, the bank's operations subsidiary may be much larger, encompassing various functions.

Credit card swipe, issuance hit a high in May on retail spending

Bounce rate at 3-year low; rising interest rates could impact with a lag

SURABHI Mumbai, June 27

Credit card issuances and spends continued to remain robust in May in an indication that the retail economy continues to be strong.

According to RBI data, there were 7.68 crore outstanding credit cards as of May, which was a 2.2 per cent increase from 7.51 crore in April. Year-on-year, this was a jump of 23.3 per cent from the 6.23 crore credit cards in force in May 2021.

Credit card spends also remained well above the ₹1lakh crore mark in May despite inflationary pressures and rising interest rates. Total credit card spending in



May was at 1.13-lakh crore, which was 7.8 per cent higher than April's 1.05lakh crore. But credit card spending more than doubled in the last year, by 17.8 per cent, from 52,200crore in May 2021.

"Latest data releases from RBI reveal that credit card spends have been very strong touching an all-time high level in May 2022," said a note by Macquarie Research, adding that the bounce rate by value is also at a three-year low. "These data points indicate that the retail economy is strong," it said but cautioned that with interest rates exp. e rapidly in the next few quarters, "we need to see whether current trends are sustainable".

Outstanding credit cards

According to Motilal Oswal, "Spends remained strong and continued their healthy momentum, led by the rising share of e-commerce transactions, which will keep growth in spends buoyant." Monthly spends per card grew five per cent to ₹14,800, much higher than pre-Covid levels, it said. The ticket size of transactions was stable at ₹4,700-4,800.

All players, barring American Express, saw an increase in monthly spends per card of up to ₹1,100; IndusInd Bank saw an increase of ₹3,900. HDFC Bank had the highest card issuances in May at about 3.85 lakh new cards.

In terms of credit cards, HDFC Bank was followed by the State Bank of India (1.41 crore) and ICICI Bank (1.33 crore) at the end of May 2022.

According to an official order issued by the Personnel Ministry, the Appointments Committee of the Cabinet cleared the name of Gupta, a 1987-batch IPS officer from Punjab, for the top NIA post.

According to the order, Gupta will hold the post of NIA chief till March 31, 2024, that is the date of his retirement or till further orders, whichev-



er comes earlier. Having a Master's degree in police administration, Gupta has held the position of Director General of Punjab Police in 2019 and served at the post for two years and seven months.

He has also held the post of Director General of Police, Intelligence, Punjab, which involved the direct supervision of the Punjab State Intelligence Wing, State Anti-Terrorist Squad (ATS) and Organized Crime Control Unit

(OCCU). An experienced and distinguished officer, Gupta earlier had an eight-year stint on central deputation from June 2004 to July 2012 during which he held sensitive assignments including as the head of the Intelligence Bureau unit which looked after the security of VVIPs. Gupta was decorated with two police gallantry medals in 1992 and 1994. TAPAN DEKA, special director in the Intelligence Bureau (IB), was on Friday appointed the new IB chief. He will replace incumbent Arvind Kumar, whose tenure comes to an end on June 30. The central government has also given a one-year extension to chief of Research and Analysis Wing (R&AW) Samant Goel, whose tenure was also set to come to an end at the end of this month.

On Thursday, the government had appointed former Punjab police chief Dinkar Gupta as the new head of the National Investigation Agency (NIA), and had also named special director in IB, Swagat Das, as special secretary in the Union Home Ministry. The new IB chief, Deka, will have a fixed tenure of two years. He has superseded his senior special director, A Sema Rajan, a 1987 batch IPS officer of the Bihar cadre, in the appointment. Deka is a 1988 batch IPS officer of the Himachal Pradesh cadre.

Deka has been handling the operations division of the IB, and has decades of experience in counter-terrorism. He was the joint director of operations when the Indian Mujahideen terror group was at the peak of its activities in the country. Under Deka, the IB tracked down Indian Mujahideen operatives over the years, and the group had been practically incapacitated since the 2012 arrest of its leader Yasin Bhatkal from Nepal and the 2014 arrest of operative Tehsin Akhtar. Deka was also handling operations during the 2015-16 Pathankot air base attack and the 2019 Pulwama attack.

He follows in the footsteps of former IB chiefs such as Ajit Doval and Nehchal Sandhu who had been handling operations before heading the agency.

Recently, Deka has been particularly focused on the security situation in Jammu and Kashmir, where civilians have been increasingly targeted in the past several months.

R&AW chief Goel's tenure extension indicates that he continues to enjoy the trust of the government. Sources said that under Goel, the agency has been generating quality intelligence on cross-border infiltration from Pakistan, resulting in effective operations by security forces against militants in Kashmir.

SamantGoel, the current head of the Research and Analysis Wing (R&AW), has received yet another year's extension to his term, which ends on June 30.



NASA's satellite, newly launched. It will test a unique lunar orbit that will be used by future missions

ON WEDNESDAY, NASA launched CAP-STONE, a microwave oven-sized CubeSat weighing just 55 pounds (25 kg). CAP-STONE, short for Cislunar Autonomous Positioning System Technology Operations and Navigation Experiment, is designed to test a unique, elliptical lunar orbit.

The satellite, launched on Rocket Lab's Electron rocket from the Rocket Lab Launch Complex 1, is heading toward an orbit intended in the future for Gateway, a Moonorbiting outpost that is part of NASA's Artemis program.

As a pathfinder for Gateway, CAPSTONE aims to help reduce risk for future spacecraft by validating innovative navigation technologies, and by verifying the dynamics of the halo-shaped orbit.

The orbit is known as a near-rectilinear halo orbit (NRHO). It is significantly elongated, and is located at a precise balance point in the gravities of Earth and the Moon. This offers stability for long-term missions like Gateway, NASA said on its website.

At the Moon, CAPSTONE will enter NRHO, where it will fly within 1,600 km of the Moon's North Pole on its near pass and 70,000 km from the South Pole at its far-

thest. The spacecraft will repeat the cycle every six-and-a-half days and maintain this orbit for at least six months to study dynamics.

CAPSTONE will gain experience with small dedicated launches of CubeSats beyond low-Earth orbit, to the Moon, and beyond, NASA said.

The spacecraft is currently in low-Earth orbit. It is attached to Rocket Lab's Lunar Photon. **SOURCE: NASA**

Nasa makes 'historic' launch from commercial site in Australia

asa's first-ever launch from a commercial site outside of the US blasted off from Australia's Outback late on Sunday, in a "historic" moment for the country's space industry.

- In the first of three planned launches from the Arnhem Space Centre, the rocket, carrying technology likened to a "mini Hubble" telescope, lifted offblasted about 350 kilometres into the night sky.
- "It is a momentous occasion for us as a company in particular, but it's historic for Australia," Equatorial Launch Australia CEO Michael Jones told AFP ahead of the lift-off.

Jones, whose company owns and operates the launch site in the far north of Australia, described it as a "coming out" party for the country's space industry and said the chance to work with Nasa was a milestone for commercial space firms in the country. After a series of rain and wind delays, the suborbital sounding rocket soared into the sky to study x-rays emanating from the Alpha Centauri A and B systems.

AHEAD OF NUCLEAR TALKS Tehran launches rocket into space as US fumes

IRANIAN STATE television said Sunday that Tehran had launched a solid-fueled rocket into space, drawing a rebuke from Washington ahead of the expected resumption of stalled talks over Tehran's tattered nuclear deal with world powers.

It's unclear when or where the rocket, christened Zuljanah, was launched, but the announcement came after satellite photos showed preparations at Imam Khomeini Spaceport in Iran's rural Semnan province, the site of Iran's frequent failed attempts to put a satellite into orbit.

The White House said it was aware of Iran's announcement and criticised the move as "unhelpful and destabilising." It said it was committed to using sanctions and other measures to prevent further advances in Iran's

ballistic missile program.

The launch comes just a day after the EU's foreign policy chief, Josep Borrell, traveled to Tehran to resuscitate negotiations over Iran's nuclear program that have stalemated for months. Borrell said on Saturday talks over the nuclear deal would resume in an unnamed Persian Gulf country in coming days, with Iranian media reporting that Qatar would likely host the negotiations.
